It was light drizzling when we landed in Seoul on 5th Feb2012. With ultra clean environment and well built roads studded with lush green landscapes, flyovers, beautiful high rise buildings, we felt like we are in a modern European city. Like any other Asians, hospitability of Koreans is appreciable. Korea started implementing e-governance project in 2001.In next nine years, it reached to peak by standing first in the United Nations summit on e-governance. All civil services are provided through single window system. Customer oriented egovernance services are given the top most priority. For the safety of the citizens (Public Relief services), a device is made available to Koreans. If it is felt like an emergency or danger, the button on the device is to be just pressed. Instantly, it will communicate to the nearest control room along with citizen's location and a rescue team will rush to the location. We visited the software data centre in Suwon. Information on Data back up and security of the data was given to us. Then we were lead to Video conferencing room. Though video conferencing is not a novelty for us, we were astonished by the spellbound progress of Koreans in a short period in the field of egovernance in totality. Next day, we visited Information Network Village. It was equipped with IT training centre, a community centre along with a cultural space with multimedia

Module No.	Module Name	Module covers
M21	Training	This module covers the complete cycle for training at all the training imparting institutions and includes (a) the preparation of the Annual Training Programme, and (b) the selection / appointment / nomination of trainers, (c) the section / appointment / nomination of trainees (d) arrangement of infrastructure required to conduct the training, and (e) eliciting feedback from trained resources in batches that have already taken place.
M22	Professional Examinations	This module includes activities that are required to be performed to conduct the various professional examinations by META.
M23	Material / Soil / Steel Testing	This module will include all activities that are required for conduction of material testing, soil testing and steel testing.
M24	Monthly/Accounts/Reconcillation/ with Treasury & AG	This module deals with mechanism to account for all types of transactions & preparing monthly account including reconcilliation of expenditure with A.G.
M25	Inspection / Audit Report Compliance	This module shall monitor the compliance of audit reports (FD & AG) and administrative inspections.
M26	Assembly / Parlimentary Questions, Reply & Assurance Monitoring	This module relates to activities involved in responding various assembly / parlimentary matters including monitoring & assurances given house.
M27	Right to Information Cases	This module elaborates the steps required to be conducted for handling the RTI applications and providing information as per the act.
M28	Asset Management	This module would cover the management aspects of the various assets under the purview of the department.
M29	Litigation Management	This module would cover the entire set of processes required to be followed for keeping record of court proceedings.
