Project Mission Teams

The head of the office is team leader and other members are so selected, who are proactive. The roles and responsibilities of Mission Teams are summarised as below:

Role of Regional level Mission Team

- Driving the implementation of ICIS in a supportive and constructive manner.
- Coordinate with the PMO and respective CPMT for the successful and sustainable implementation of the initiative.
- Frequently and publicly promoting his/her commitment to the ICIS project,
- Emphasising the case for change (i.e. why the ICIS needs to be introduced) and the relevant benefits of the change for the target stakeholder group
- Understanding and committing to the requirements for the change initiative to succeed (e.g. time out for training) at their divisions
- Ensuring that the team driving the ICIS project at circle level has or has access to the most appropriate skills to ensure success
- Communicating and engaging with stakeholders across the region for ICIS project implementation, roll-out and sustenance;
- Behaving as an inspirational role model for others to follow
- Empowering others in the Region (e.g. Change Ambassadors) to take responsibility for delivering the vision of the ICIS project
- Convene regular project review meeting, tracking project risks and issues and escalating risks to PMO and enabling identification and implementation of the mitigation strategy for the each of the identified risk or issues.
- Provide the necessary guidance and support to the respective CPMT on an on-going manner during the project implementation and later operation & maintenance phase of the project.
- Become role models for other CPMT across the WRD for the ICIS project.

- Convening weekly project status meeting, tracking project risks and issues and escalating risks to RPMT and Project Management Team Members as appropriate

- Some of the major responsibilities to be undertaken by the CPMT are:
- Implementation support for the project during Pilot, Roll-out and 0&M phases.
- Co-ordinate and ensure faster and successful Data Digitization of legacy data across each of the circles
- Change management:
- Identification of the employees for training/change management workshops
- Evaluation of training effectiveness
- Roll out of effective communication and awareness plan across various stakeholder of the circle
- Gathering timely and regular feedback from the key stakeholders of the project
- Training:
- Planning and arranging the trainings for the department official and users as and when required
- Preparation of the training Calendar in consultation with the PMO
- Participate as Master trainers Change Champions for various modules as required
- Communicate with institutes where ICIS training programs could be rolled out regularly; such institutes include RTCs, META, WALMI
